There have been various concerns raised with me about a local resident to Upchurch: I have been aware of this resident and have worked with them and those immediately impacted by them over the last few months. I have also had to request Facebook posts be removed of which were naming this resident and sometimes speculating incorrectly about the persons history. I have worked with the housing provider and persuaded them that a move for this person is best for all concerned. This has proved difficult as although many Facebook posts alleging certain offences, there were limited if any calls to the police about the same matters and no complaints until recently to the housing provider. Please can I ask anyone that has social media, that whilst it is a great tool to quickly warn others of something, if misused it can be damaging to any criminal investigation and if inaccurate can open individuals up to libel claims. Please report any criminality directly to the police; the police do not police social media.

Fraud and Cybercrime

I have organised for a colleague of mine to deliver an input to the UpARA on Friday 30th August about fraud and cybercrime. This input focusses on what to look out for and how to protect yourself from being a victim of this type of crime. If this is something the wider community would benefit from, a further time and date could be arranged for a further input.
